I am aware of and consent to the following: any personal data concerning me which appear on this visa application form will be supplied to the relevant authorities in the Schengen states and processed by those authorities, if necessary, for the purposes of a decision on my visa application. Such data may be input into, and stored in, databases accessible to the relevant authorities in the various Schengen states. At my express request, the consular authority processing my application may inform me of the manner in which I may exercise, via the central authority of the state which input the data, my right to check the personal data concerning me and have them altered or deleted, in particular, should they be inaccurate, in accordance with the national law of the state concerned. I declare that to the best of my knowledge all particulars supplied by me are correct and complete. I am aware that any false statements will lead to my application being rejected or to the annulment of a visa already granted and may also render me liable to prosecution under the law of the Schengen state which deals with the application. I undertake to leave the territory of the Schengen states upon the expiry of the visa, if granted. I have been informed that possession of a visa is only one of the prerequisites for entry into the European territory of the Schengen states. The mere fact that a visa has been granted to me does not mean that I will be entitled to compensation if I fail to comply with the relevant provisions of Article 5.1 of the Schengen Implementing Convention and am thus refused entry. The prerequisites for entry will be checked again on entry into the European territory of the Schengen states. 我知道并同意以下条款: 本签证申请表上关于我的任何个人资料, 将被提交给有关申根国家的相应机构, 以便用于审理我的签证申请。此资料可以被输入并存储在申根国家的相关机构的数据库中, 并由各申根国家的有关机构使用。 如我明确请求, 对我的申请进行审理的使领馆应通知我, 以何种方式可以行使核查有关我的个人资料并依据有关国家法律规定更改或删除错误数据的权利。 我声明, 就我所知, 我提供的一切资料都是正确和完整的。 我知道, 任何虚假陈述都将导致拒绝签证或已发签证的废止, 也可以根据对我的申请进行审理的申根国家的法律规定进行刑事追究。 如果签证申请被批准, 我保证在签证到期时离开申根国家领土。 我获悉, 拥有签证只是进入欧洲申根国家领土其中的一个条件。如果没有履行申根执行公约第五条第一款规定的条件而被拒绝入境, 那么仅仅拥有签证并不意味着我有权就此要求赔偿。在进入欧洲申根国家的领土时, 入境条件再次受到审查。
